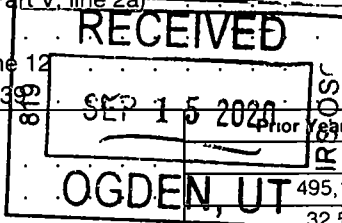

One is for ~3,000 high school students and takes place in February and the other is for college students and has ~600 participants.

The National American Invitational Model United Nations (NAIMUN) is a conference for high school students. We have approximately 3,000 students who partake in this conference. During the conference, volunteers run simulations of various global bodies and governments at a hotel in Washington, D.C. We allow for high school students to become intimately acquainted with international relations and to build their skill set in the areas of public speaking, writing, research, and innovative thinking. The conference is completely run by students at Georgetown University, providing our volunteers with valuable experience in the realms of organization as well as leadership.

These are the figures for Georgetown International Relation Association's program NCSC XLVII. NCSC is a college model United Nations conference. During the conference we have college students from around the United States unite to engage in simulations of various situations in international relations. Our conference sees the participation of approximately 800 students. Through simulations we help students build their knowledge base as well as the ability to solve global problems. Simulations require the students to think innovatively, engage in public speaking, and work in a team to come up with solutions to pressing global issues. Overall during the conference we run approximately 20 simulations.
